### **Policies & Guidelines for Trip to Wreck Site Emerald City & Dive Trips - Thursday, May 17th - Friday, May 25th**

This is a quick outline of our policies regarding your trip to the Atocha/Margarita site. Please refer to the complete copy in the Investor Relations/ Trip Planner section of our website – [www.melfisher.com](http://www.melfisher.com)

**You must be a current investor (contract has not expired)  
at the time of the trip in order to participate in that trip.**

For your safety and the safety of others around you, please read and follow the information and guidelines.

**Transferring from the taxi boat to the salvage vessel can be challenging. You must be able to move quickly and have the ability to climb a ladder on a rocking boat. For your own safety, please judge for yourself as to whether you are physically capable of performing this type of activity.**

**If diving, you must be a qualified, strong, experienced and self-sufficient diver and meet the requirements described in your Trip Pack.**

1. Trips are conducted daily during daylight hours only. No overnight visits are permitted.
2. Before leaving for the site passengers must have read, understood, completed and submitted the following paperwork/items from your trip pack to a Mel Fisher's Treasures representative:
  - Sign a Boat Release form and Policy & Guidelines Form.
  - Copy of driver's license
  - Copy of Diver Certification card (if diving)
  - Scuba Diver Guidelines and Required Equipment Check List (if diving)
  - Trip Tickets which you will receive via email after you call in your trip reservations.  
Please note that these tickets are just like receiving concert or show tickets – No Tickets, No Trip.
3. Pack a lunch – please bring whatever you would like to eat and drink for the day. **No alcoholic beverages.**
4. Dress for the weather. Suntan lotion is always a good idea!
5. If you get involved in recovering treasure and artifacts aboard one of the salvage vessels, upon finding such items you must immediately turn the item(s) over to the Captain. The Captain will provide you a tag number so that you may identify and receive that item in your division.
6. **No one under the age of 18 is allowed to visit the site.**
7. **All trips to the site are WEATHER PERMITTING.**
8. **Although there is no charge to go out to the site, we will require a credit card # at the time we take your reservation. If you need to cancel your reservation we need 48 hours advance notice so that we have time to offer the seat to other investors. Cancelled reservations with less than 48 hours notice and no shows will be charged \$100.00.**

### **Scheduling Appointment To Pick Up Your Division**

Please be on time for your appointment and give plenty of notice if you need to change your appointment. This request is out of courtesy for all investors.

At the time you call to schedule your division appointment be sure to inquire about the possibility of visiting the Atocha wreck sites. Remember, space is limited and it is on a first call – first served basis.

Scheduling for all division events well in advance is very important. For safety purposes, we can only accommodate a limited number of investors on the salvage boats and during appointments at any one time.
